The Bavarian Film Center organizes in cooperation with the International Filmfest München the first competition and exhibition for narrative VR in Munich on July 2nd – 4th, 2019.

Part of this event will be the **PROFESSIONAL DAY on July 3rd** in the Munich Gasteig with keynotes and talks from international guests for the public, and an exclusive **B2B MARKET** for registered and hand-picked industry professionals and potential financing partners only.

Eligibility

Projects can be in all formats of VR, AR, MR or 360° Film.

The projects can be fiction, documentary, series or animation, original concepts and adaptations.

Each project should be preferably in a development phase, but experiences already partially or completely realized are also acceptable.

Each project must be submitted by a production company / producer who own full rights to develop and produce the project.

Language of presentation and b2b market will be English. We can only accept projects submitted in English language.

By submitting the form, you declare to own all copyrights to the project or the rights to use the project. By submitting the project, you also declare that the project is free of rights of the third party.

How to submit

Multiple links/projects are not allowed in one application. Each project has to be submitted separately.



The entry is only valid if the completed form is submitted online and your project documents are sent to us via WeTransfer or mail attachment at proday@filmzentrum.net.

We will inform you by e-mail or phone about your participation in the festival until May 16th latest. Please provide us with your updated contact information in case of changes.

Application without project

You can also apply to participate without project. We are looking for decision-makers, producers, financing partners and industry professionals.

Your application will be confirmed until May 16th. Participation on the b2b market is only possible with confirmed registration.

Privacy and Photo Sharing

This declaration is part of the conditions of participation for the “VIRTUAL WORLDS – INTERNATIONAL COMPETITION & EXHIBITION” on JULY 2nd to 4th in MUNICH (“event”).

Consent according to DSGVO

Hereby you declare your consent that we store your personal data in connection with your participation in the event, but also thereafter to receive further information about the activities of the Bayerische Filmzentrum and will be used by the Bayerischen Filmzentrum for these purposes. Your data will not be passed on to third parties for commercial purposes. The data will only be passed on:

- if the disclosure is necessary for asserting, exercising or defending legal claims pursuant to Art. 6 para. 1 sentence 1 f DSGVO and there is no reason to assume that you have an overriding interest worthy of protection in not disclosing your data,
- in the event that a legal obligation exists for the transfer pursuant to Art. 6 para. 1 sentence 1 lit. c DSGVO, and
- this is permitted by law and is required by Art. 6 para. 1 sentence 1 b DSGVO for the handling of employment and/or contractual relationships with you.

As the data subject, i.e. as the person whose personal data is collected, you have certain rights pursuant to Art. 7, 15-21 DSGVO. This includes the following rights in particular:

- the right to **request information** about your personal data processed by us. We hope that we fulfil this requirement by means of this data protection declaration.
- to demand the right to **delete** your personal data stored with us, unless the processing is necessary to fulfil a legal obligation or to assert, exercise or defend legal claims;
- the right to **revoke** your consent to us at any time or, if your personal data are processed on the basis of legitimate interests in accordance with Art. 6 para. 1 sentence 1 letter f DSGVO, to **object** to the processing of your personal data, and
- to complain to a supervisory authority pursuant to Art. 77 DSGVO. As a rule, you can contact the supervisory authority of your usual place of residence or the headquarters of the Bayerische Filmzentrum.

You also agree that the Bayerisches Filmzentrum may use video and audio recordings, recordings and photographs ("recordings") made during the event for promotional purposes in all media for an unlimited period of time. This includes the right of the Bayerisches Filmzentrum to store and archive the recordings.
